Introduction

The University of Arizona College of Medicine-Phoenix (UACOM-P) has developed a robust wellness and mental health program for medical students & trainees.

- Fulltime Director of Wellness (UME and GME)
- Three fulltime psychologists (2 UME and 1 GME). Dedicated budget/funding
- Dedicated curricular time/opportunities
- Dedicated 'wellness time' for mental health and PCP appointments
- Dedicated wellness space (4000 sq. ft. for medical trainees at the main clinical site)
- Dedicated debrief/processing groups
- Established Wellness Committees at the College and primary clinical site (UME, GME, Faculty)
- Annual evaluations/assessments (UME and GME)

Implementation/Innovation

The Director of Wellness in partnership with the committees:

- Built and gathered data from a variety of needs assessments/evaluations/internal data
- Worked with faculty to incorporate wellness topics into their blocks
- Hosted a wellness retreat for strategic planning/growth
- Advocated for dedicated space from hospital leadership
- Developed proposals and worked with administration to receive dedicated annual funding for programs, workshops, and mental health resources
- Shadowed medical students and residents on their rotations to review and understand barriers
- Held listening and discussion groups with medical trainees
- Developed one-stop-shop website for all wellness and mental health resources (wellness.arizona.edu)
- Established well-being milestones around ACGME requirements

- Developed a five-year strategic plan for UME wellness
- Dedicated Personnel FTE
- Program budget/resources
- Curricular time

GME Development

- Developed a two-year strategic plan
- Dedicated wellness space
- Dedicated personnel
- Program budget/resources
- Curriculum
- Mental health resources

GME Wellness Curriculum and Content

- Resident and Fellow Orientation Wellness and Mental Health Presentation
- Monthly mandatory ICU processing/debriefs sessions
- Wellness Week (varying wellness topics, programs, & workshops)
- Mental Health Awareness Week (4-5 mental health programs & workshops)
- Annual program specific presentations (variety of wellness topics)
- Wellness Seminar Series (CME Credit)
- QPR Suicide Prevention Training (multiple months)

UME Wellness Curriculum and Content

- New Student Retreat (3 days/2 nights in Northern, AZ)
- Introduction to wellness, help-seeking, and mindfulness
- Introduction to personal bias and new perspectives
- Introduction on learning: Learning to learn workshop Introduction on communication types and being an effective leader
- Introduction to professional development: The progression of specialty
- The impact of mindset on success
- Resiliency 101
- Introduction to privilege and its impact in medicine
- Introduction to the importance of diversity in medicine
- Working as a team to achieve common goals

- Wellness Week (varying wellness topics and workshops all week)
- QPR Suicide Prevention Training (multiple months)

Annual Events:

- Wellness Welcome Lunch
- Wellness Olympics
- Fall Fest
- Destress popcorn/coffee events (monthly before major exams)
- Therapy Dogs (4x per year) Weekly Student Lead Mindfulness Meditation
- Student Lead Yoga
- Student Wellness Executive Committee Events (3-4 annually)



Lessons Learned

- Developing an integrated wellness program that has the resources, influence, and a reputation for creating change is anything but linear

Conclusion

- Having dedicated wellness personnel and a program has been the largest impact to improving medical trainee well-being
- The program and positions formed a natural place for students/trainees to reach out to with any wellness or mental health topics/concerns
- The dedicated position allowed for focus on needed systems changes, practices and policy updates while also providing training and programming
- The position became a natural safe contact for those in crisis, needing help, and/or experiencing mistreatment
- The wellness program became a psychologically safe place to discuss many of the taboo subjects and frustrations in the medical training environment.
